- 4. The age as per SRO. 165 of 2014, Dated: 09-06-2014 shall be minimum 18 years and not more than 40 years. However upper age ceiling of 43 years for reserved category candidates, 42 years for Physically Challenged candidates and 48 years in case of Exserviceman candidates as on 01-01-2016 shall be accepted.
