- 1. The engagement shall be purely on Term Contract Basis for one year only. Contract shall be liable to be terminated without any notice in case of performance below acceptable standard.
- 2. The candidate shall fulfill all the eligibility criteria mentioned for the post.
- 3. The candidate should be a permanent resident of the State of Jammu & Kashmir.
- 4. The age as per SRO. 165 of 2014, Dated: 09-06-2014 shall be minimum 18 years and not more than 40 years in case of General category candidates, 43 years for reserved category candidates 42 years for physically challenged candidates and 48 years in case of Ex-serviceman candidates as on 01-01-2016.
